

SCRT Scholarship Program

SCRT is pleased to offer its “Regular Member” companies a scholarship opportunity to help advance training and education for company owners or staff. It is the desire of SCRT to help defray the cost of IICRC-approved courses leading to certification, full registration for The Experience Convention, or registration fees for SCRT-sponsored workshops. \$450.00 per quarter will be awarded in scholarships.

Only SCRT “Regular Member” companies in good standing for more than one year at the time of the event are eligible to participate. Members who pay dues quarterly and “Associate Members” are not eligible to participate. New members are eligible for scholarships up to \$100.00 until they have been a member for one year.

The scholarships are intended to help underwrite the cost of the approved event and not for personal, travel, lodging or per diem expenses. Fees will be paid directly to the event’s sponsor.

Scholarship Guidelines

1. Scholarships will be used for training events pre-approved by SCRT.
2. Before being processed, scholarship application must include the following:
 - **Completed** application form. Areas left blank may cause delay or rejection of the application.
 - A brochure, flyer or announcement of the event, describing the program content, dates, location and cost.
3. Completed application materials must be submitted for consideration and approval to SCRT headquarters at least 15 days prior to the first day of the event, but no sooner than 60 days prior. (For example: Event date March 1 – apply by February 14, but not before January 1.)
4. It is the responsibility of the SCRT Member Firm to register for the training event. SCRT will not coordinate student attendance or provide administrative assistance in preparation for the event.
5. SCRT **must** be notified if a scholarship recipient cancels or does not attend an event. Any monies not refunded to SCRT, due to SCRT Member non-attendance without prior notification, will be charged to the SCRT Member Company.
6. Each SCRT “Regular Member” company is eligible to apply for up to \$300.00* in scholarship funding per calendar year. *(increased July 2010)
7. Not all applications will be approved since funding is limited. Priority will be given to the date application is received and the number of previous scholarships received by a SCRT Member Company.

The SCRT may, at its discretion, change the Scholarship program rules, regulations and awards at any time, with or without notice. The SCRT reserves the right to end the Scholarship program at any time with or without notice. SCRT Members may not rely on the continued availability of any Scholarship. Any Scholarship may be withdrawn or subject to increased requirements with respect to credits or benefits. SCRT may withdraw, limit, modify or cancel any scholarship, change program benefits, conditions of participation, rules for earning, retaining or forfeiting Scholarships, or otherwise restrict the continued availability of the Scholarship.
